1. Election of Chairman

RESOLVED: All members agreed that Cllr David Howson be appointed Chairman for the ensuing year. **ACTION:** The declaration of acceptance of office will be signed by the Chairman before the Clerk at the next face to face parish council meeting.

2. Election of Vice Chairman

RESOLVED: All members agreed that Cllr Ruth Reed be appointed Vice Chairman for the ensuing year.

- ii. RESOLVED: To adopt the following updates to the Financial Risk Assessment with immediate effect:
 - Items 2 & 3: Change the name of the PC's insurer from Hiscox to AXA Insurance UK PLC.
 - Item 4: Add the term "employee dishonesty" after "fidelity guarantee" to reflect the wording in the current insurance policy.
 - ➤ Item 9: Change the wording to reflect that the external auditor is now appointed by Smaller Authorities' Audit Appointments Ltd.
